CCMC - 18.02.005 Short title.

1. This title shall be known and may be cited in all proceedings as the Carson City Zoning Ordinance. (Ord. 2001-23 § 2 (part), 2001).

18.02.007 Power of board of supervisors (hereinafter in Title 18 referred to as "board")-Zoning and planning.

- 1. The board may:
- a. Divide Carson City into districts and regulate and restrict the erection, construction, reconstruction, alteration, repair or use of buildings. structures or land within those districts.
- b. Adopt master plans for Carson City which will serve as a pattern and guide for the kind of orderly physical growth and development of the city that will minimize impairment of the city's natural resources.
- c. Establish and adopt ordinances and regulations relating to the subdivision of land.
- 2. The board shall carry out the provisions of subsection 1 in the manner prescribed by Chapters 278 and 278A of Nevada Revised Statutes (NRS). (Ord. 2001-23 § 2 (part), 2001).

18.02.010 Planning commission.

- 1. Purpose. The purpose of this ordinance is to specify the establishment and authority of the Carson City Planning Commission (hereinafter in Title 18 referred to as "commission".
- 2. Authority; powers; duties; review by the board.
- a. The commission is hereby created, pursuant to NRS 278.030.
- b. The commission shall perform all duties and functions delegated to a County Planning Commission by the terms of NRS 278.010 to 278.630, inclusive, and CCMC Title 2 (Planning Commission)
- c. The commission shall take action to approve, conditionally approve or deny special use permits, variances, and appeals of administrative decisions. The commission shall hear applications and recommend to the board action on changes to the Master Plan, zoning districts, amendments to Title 18 ordinances, amendments to the Development Standards, and all other appropriate subjects.
- d. On matters where the commission takes final action, the proponent, any aggrieved party, or member of the board may appeal the decision to the board.
- e. On matters where the commission makes a recommendation to the board, the board by majority vote may affirm, deny, or return to the recommendation to the commission for further consideration of any proposed recommendations.
- 3. Membership; terms of office; vacancies; removal; attendance by director.
- a. There shall be seven (7) members of the commission.
- b. The terms of the members shall be four (4) years or until a successor takes office and all terms shall expire on June 30th of their respective years.
- c. Vacancies occurring before the expiration of a commissioner's term shall be filled for the remaining unexpired portion of the term.
- d. Members may be removed, after a public hearing, by a majority vote of the board for inefficiency, neglect of duty. or malfeasance of office.

- e. The Planning and Community Development Director (hereinafter in Title 18 referred to as director) or his designee shall be in attendance at all commission meetings.
- 4. Qualifications.
- a. The mayor shall appoint, with the approval of the board, the members of the commission.
- b. The members shall be residents of Carson City and registered voters therein at the time of their appointment and continuously throughout their term.
- 5. Compensation. All members of the commission shall serve without compensation.
- 6. Meetings and Records.
- a. The commission shall hold at least one (1) regular meeting in each month.
- b. The commission shall adopt by-laws and rules for the transaction of their business and shall keep a record of its decisions and findings. This record shall be a public record.
- c. Complete records of official actions of the commission shall be kept on file in the office of the planning and community development department.
- 7. Chairman and Other Officers.
- a. The commission shall elect yearly its chairman from among the appointed members.
- b. The commission shall elect yearly other offices as it my determine necessary. (Ord. 2001-23 § 2 (part), 2001).

2. Before submitting a recommendation for proposed legislation or beginning any program or project relating to the mandatory provisions of the comprehensive regional plan, a unit of local government or an affected entity shall file all relevant information relating to that request, program or project with the governing board. (Added to NRS by 1989, 766)

NRS 278.0288 Exempted region. The region defined in NRS 278.790 is exempt from the provisions of NRS 278.026 to 278.029, inclusive, and 278.145. (Added to NRS by 1989, 766; A 1991, 954)

NRS 278.029 Facilities plan not required. Nothing contained in the provisions of NRS 278.026 to 278.029, inclusive, requires any entity that has not already adopted a facilities plan to do so.

PLANNING COMMISSIONS

NEVADA CASES.

Citizens could not use the initiative process to invoke an administrative act. Where a group of concerned citizens attempted, by way of the initiative process (see Nev. Art. 19, §§ 2 and 4), to require a county to preserve in perpetuity a particular park and fairgrounds, the supreme court explained that although the initiative process applies to legislation, it does not apply to administrative acts. Because issues of the control, management and disposal of county real property (see NRS 244.281, 244.282 and 278.030 et seq.) are

governed by statute, with the applicable statutory provisions to be carried out by local governmental entities, the proposed initiative to preserve the park and fairgrounds amounted to an improper attempt to control administrative acts, rather than a permissible attempt to legislatively create a new course of policy. Glover v. Concerned Citizens for Fuji Park, 118 Nev. _____, 50 P.3d 546 (2002)—(Adv. Op. No. 52), cited, Citizens for Pub. Train Trench Vote v. City of Reno, 118 Nev. ____, at ____, 53 P.3d 387 (2002)—(Adv. Op. No. 60), AGO 2002-33 (9-11-2002)

NRS 278.030 Creation by cities and counties; number of members.

1. The governing body of each city whose population is 25,000 or more and of each county whose population is 40,000 or more shall create by ordinance a planning commission to consist of seven members.

2. Cities whose population is less than 25,000 and counties whose population is less than 40,000 may create by ordinance a planning commission to consist of seven

members. If the governing body of any city whose population is less than 25,000 or of any county whose population is less than 40,000 deems the creation of a planning commission unnecessary or inadvisable, the governing body may, in lieu of creating a planning commission as provided in this subsection, perform all the functions and have all of the powers which would otherwise be granted to and be performed by the planning commission.

ATTORNEY GENERAL'S OPINIONS.

Creation of a planning commission is optional with a governing body. In counties having less than 15,000 (now 25,000) population, the governing body of the city or county may dissolve its planning commission, because, under NRS 278.030, the creation of a planning commission is optional with the governing body. AGO 20 (4-23-1971)

NRS 278.040 Members: Appointment; qualifications; compensation and expenses; terms; removal; vacancies.

1. The members of the planning commission are appointed by the chief executive officer of the city, or in the case of a county by the chairman of the board of county commissioners, with the approval of the governing body. The members must not be members of the governing body of the city or county. The majority of the members of the county planning commission in any county whose population is 400,000 or more must reside within the unincorporated area of the county.

2. In Carson City, the members of the planning commission established as provided in NRS 278.030 are appointed by the Mayor from the city at large, with the

approval of the Board of Supervisors.

3. The governing body may provide for compensation to its planning commission in an amount of not more than \$80 per meeting of the commission, with a total of not more than \$400 per month, and may provide travel expenses and subsistence allowances for the members in the same amounts as are allowed for other officers and employees of the county or city.

4. Upon compliance with the terms of the ordinance, the owner or operator of the theme park or permanent exhibition is not required to acquire any license or certificate from a state agency which would otherwise be required to operate a lift, tramway, monorail, elevator, escalator, roller coaster or other conveyance used primarily in connection with the theme park or permanent exhibit.

NRS 268.098 City's powers subordinate to powers of Nevada Tahoe regional planning agency. [Effective upon proclamation by governor of withdrawal of California from Tahoe Regional Planning Compact or of his finding that the Tahoe Regional Planning Agency has become unable to perform its duties or exercise its powers.] In the region of this state for which there has been established by NRS 278.780 to 278.828, inclusive, a regional planning agency, the powers of every city which relate to planning, subdivision regulation and zoning are subordinate to the powers of such regional planning agency.

(Added to NRS by 1969, 51; A 1979, 1133, effective upon proclamation by governor of withdrawal of California from Tahoe Regional Planning Compact or of his finding that the Tahoe Regional Planning Agency has become unable to perform its duties or exercise its powers)

NRS 268.099 City's powers subordinate to powers of regional planning agency. In any region of this state for which there has been established by interstate compact a regional planning agency, the powers conferred by this chapter which relate to planning, subdivision regulation and zoning are subordinate to the powers of such regional planning agency.
