Subject Title: Action to determine that V & C Construction, Inc. is the lowest responsive and responsible bidder pursuant to N.R.S. Chapter 338 and to award Contract No. 0910-139 East Washington Street C.D.B.G. Pedestrian Improvements to V & C Construction, Inc. for a bid amount of \$248,483.50 plus a contingency amount not to exceed \$31,516.50 to be funded from the Capital Project/ADA Sidewalks Downtown as provided in FY 2009/2010.

Staff Summary: Carson City received sealed bids for all labor, materials, and equipment necessary for the East Washington Street C.D.B.G. Pedestrian Improvements. The project consists of installing new sidewalks, pedestrian ramps, stairs, railing, driveways, valley gutter and curbs, removing existing structures, asphalt concrete, pavers, gravity wall and signs. The project includes all common phase of construction customarily associated with this type of work.

Time of completion for this project is sixty (60) calendar days from the date of the Notice to Proceed anticipated to be March 22, 2010.
