**Subject Title:** Action approve Contract No. 1011-177 pursuant to NRS 332.115(1)(b); to find that Susan Pintar, M.D. is qualified to serve as the Carson City Health Officer; to appoint Susan Pintar, M.D. as the Carson City Health Officer pursuant to CCMC 9.01.030 to CCMC 9.01.050; to set the compensation of the Health Officer at a not to exceed amount of \$15,000.00 per calendar year, to paid in equal monthly payments of \$1,250.00 from January 1, 2011 through December 31, 2012, to be funded from the Health Administration Professional Services Fund as provided in FY 2010/2011. **Staff Summary:** Susan Pintar, M.D. was appointed the City's Health Officer and said appointment must renewed every two (2) years, unless a successor has been qualified and appointed (NRS 438.290 and CCMS Section 9.01.040). Carson City Health and Human Services is confident that Dr. Pintar's experience, training, and commitment to public health will enable her to successfully provide this service for Carson City.

**Recommended Board Action:** I move to approve Contract No. 1011-177 pursuant to NRS 332.115(1)(b); to find that Susan Pintar, M.D. is qualified to serve as the Carson City Health Officer; to appoint Susan Pintar, M.D. as the Carson City Health Officer pursuant to CCMC 9.01.030 to CCMC 9.01.050; to set the compensation of the Health Officer at a not to exceed amount of \$15,000.00 per calendar year, to paid in equal monthly payments of \$1,250.00 from January 1, 2011 through December 31, 2012, to be funded from the Health Administration Professional Services Fund as provided in FY 2010/2011. **Explanation for Recommended Board Action:** Pursuant to NRS 439.290 and 439.300 the Board of Supervisors must appoint a county health officer and set compensation for that position. This position would be paid for through the general fund. In appointing the health officer, the Board of Supervisors must consider the candidate's education in public health, his training, his experience, and his interest in public health and related programs. The term of Officer is for two (2) years or until a successor is appointed and qualified.

**NRS 332.115 subsection 1(b)**, staff is requesting the Board of Supervisors declare that this contract is not adapted to competitive bidding and to award contract.

# CONTRACT FOR SERVICES OF INDEPENDENT CONTRACTOR

Titled: Health Officer

**THIS CONTRACT**, made and entered into this 1<sup>st</sup> day of January, 2011, by and between the City and County of Carson City, a political subdivision of the State of Nevada, hereinafter referred to as the "**CITY**", and Susan R. Pintar, MD hereinafter referred to as the "**CONTRACTOR**".

## WITNESSETH:

**WHEREAS**, the Purchasing and Contracts Coordinator for the City and County of Carson City is authorized, pursuant to Nevada Revised Statutes Chapter 332 and Carson City Purchasing Resolution #1990-R71, to approve and accept this Contract as set forth in and by the following provisions; and

**WHEREAS**, it is deemed that the services of **CONTRACTOR** for **CONTRACT No. 1011-177 Health Officer** are both necessary and in the best interests of **CITY**; and

**NOW, THEREFORE**, in consideration of the aforesaid premises, the parties mutually agree as follows:

1 **REQUIRED APPROVAL:**

1.1 This Contract shall not become effective until and unless approved by the Carson City Board of Supervisors.

2 **CONTRACT TERM:**

2.1 This Contract shall be effective from January 1, 2011, subject to Carson City Board of Supervisors' approval (anticipated to be December 16, 2010) to December 31, 2012, unless sooner terminated by either party as specified in **Section 7 Contract Termination**.

3 **NOTICE:**

3.1 Unless otherwise specified, termination shall not be effective until thirty (30) calendar days after a party has served written notice of default, or without cause upon the other party. All notices or other communications required or permitted to be given under this Contract shall be in writing and shall be deemed to have been duly given if delivered personally in hand, by e-mail with simultaneous regular mail, by telephonic facsimile with simultaneous regular mail, or by certified mail, return receipt requested, postage prepaid on the date posted, and addressed to the other party at the address specified below.
