Mr. Hamilton explained the need to extend the matter for ninety days to complete the standards. The Applicant for Item U-87-37 had formally withdrawn the appeal. Mr. Cockerill then read the stipulations and related permit and signatures. The public hearing had been scheduled for 7:30 p.m. on October 1. Negotiations between the staff and representatives of the billboard industry on acceptable standards were continuing. The result of these discussions would culminate in a serious reading of the Ordinance on October 8. Mayor Flammer explained comments which had been made about continuing the matter to an evening meeting due to the attorney costs. Mr. Cockerill explained that the hearing had been scheduled for an evening meeting so that more of the public could attend. Supervisor Swirczek supported the proposal.

Supervisor Feticc then moved that the Chief District Attorney Charlie Cockerill be authorized to sign the stipulations. Supervisor Swirczek seconded the motion. Motion was voted and carried 5-0. Mr. Cockerill stated

for the record that he would sign the stipulations at this time and file them with the Clerk.

Supervisor Feticc then moved to continue the matter to the first meeting in October 1987. Supervisor Swirczek seconded the motion. Clarification indicated that Special Use Permit U-87-33 had been in Mr. Bowen's list. The motion to continue the matter was voted and carried 5-0.

Supervisor Feticc then moved to adjourn. Supervisor Swirczek seconded the motion. Mayor Flammer, while acknowledging the need for occasional absenteeism, explained the need for a full Board at the meetings and suggested that the second meeting in July be held on July 30. The motion to adjourn was voted and carried 5-0. Mayor Flammer adjourned the meeting at 6:20 p.m.
