A meeting of the Carson City Liquor and Entertainment Board was held during the regularly scheduled Board of Supervisors session on Thursday, July 15, 2004, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, beginning at 8:30 a.m.

Mayor Masayko recessed the Board of Supervisors session and immediately convened the Liquor and Entertainment Board by noting a quorum was present, including Member Furlong. (For the Board of Supervisors Minutes, see its folder for this date.)

BUSINESS LICENSE - Deputy Treasurer Merlene Alt

A. ACTION TO APPROVE A BEER AND WINE LICENSE FOR CHIEN CHUNG CHENG DOING BUSINESS AS EAST OCEAN CHINESE RESTAURANT LOCATED AT 1214 NORTH CARSON STREET (1-0081) - Chairperson Masayko explained the requirement that Mr. Cheng be present. Mr. Cheng assured the community that neither he nor his employees would serve minors. Chairperson Masayko also explained the Code requirement that the Sheriff's Officers be allowed access to the premises at all reasonable times when in the pursuit of their duties. Member Furlong indicated the Sheriff's investigation was favorable. Member Livermore moved to approve a beer and wine license for Chien Chung Cheng, DBA East Ocean Chinese Restaurant, located at 1214 North Carson Street, fiscal impact is \$500 original new fee, \$500 investigation fee, and \$150 quarterly fee. Member Staub seconded the motion. Motion carried 6-0.

B. ACTION TO APPROVE A FULL BAR LIQUOR LICENSE FOR MIGUEL DIAZ DOING

BUSINESS AS EAST OCEAN CHINESE RESTAURANT LOCATED AT 1214 NORTH CARSON STREET (1-0145) - Chairperson Masayko reiterated the requirement that Mr. Diaz attend the meeting. Mr. Diaz assured the Board and community that he would not serve minors and would adhere to the law as a parent. He also indicated that his employees would adhere to the laws. He agreed to allow the Sheriff's Officers to have access to the premise at all reasonable times when in the pursuit of their duties. Member Furlong indicated that the Sheriff's Office did not object to his licensing. Mr. Diaz indicated that he would neither serve nor allow access to alcoholic beverages through the drive-up window. Member Aldean moved to approve a full bar liquor license for Miguel Diaz, DBA El Mariachi Loco, located at 557 South Saliman Road, fiscal impact is \$1,000 original new fee, \$500 investigation fee, and \$200 quarterly fee. Member Williamson seconded the motion. Motion carried 6-0.

C. ACTION TO APPROVE A BEER AND WINE LICENSE FOR ROOP, INC., DOING BUSINESS AS INDIA CURRY LOCATED AT 2329 NORTH CARSON STREET WITH SEWA BHINDER, KULWINDER SINGH, GURDEEP SINGH, AND BISHAN SINGH AS LIQUOR MANAGERS (1-0205) - The four applicants were present. They assured the Board that they will take their obligations seriously and provide training for their employees. Chairperson Masayko explained that the Sheriff will and does perform sting operations to verify compliance with the Codes and Statutes. They agreed to allow the Sheriff's Officers to have access to the premise at all reasonable times when in the pursuit of their duties. Member Furlong indicated that the Sheriff's Office did not object to their licensing. Member Staub moved to approve a beer and wine license for Roop, Inc., DBA India Curry, located at 2329 North Carson Street, with Sewa Bhinder, Kulwinder Singh, Gurdeep Singh, and Bishan Singh as Liquor Managers; fiscal impact is \$500 original new fee, \$725 investigation fee, and \$150 quarterly fee. Member Williamson seconded the motion. Motion carried 6-0. Discussion indicated that the establishment will open at the end of the month. The Board thanked the applicants for their investment in the community.

There being no other matters for consideration, Chairperson Masayko adjourned the Liquor and Entertainment Board.
