

ACTION PLAN FOR KATIE'S BAR

Subject: Chew, Kil Ye a/k/a Katie's Bar

I, Kil Ye Chew, owner and operator of Katie's Bar, hereby agree to the following steps in accordance to the Action Plan advised by my attorney Richard A. Molezzo, Esq., and the Carson City Sheriff's Office:

- 1. I do hereby agree to provide security emphasizing both entrance and exit to my business, during anytime there is a special event, live band or promotional event and also on Friday and Saturday nights between the hours of 9:00 p.m. until closing;
- 2. The security staff will do ID checks at all entry doors. ID checks will also be performed by all bartender's and servers where it is reasonable believed a person is under age.
- 3. I hereby agree and state that my business does have a video security system and this system is operational;
- 4. I hereby agree that the Security Staff will do frequent parking lot checks for underage drinking, and other nefarious activities. I will notify my employees to immediately contact the Carson City Sheriff's office of any crime or possible criminal activities that is discovered on the property. Failure to immediately report such instances may result in Liqueur License Revocation;
- 5. I hereby agree to fully cooperate with the Carson City Sheriff's Office or any other duly authorized Law Enforcement Agency and will allow said agencies into the building commonly known as "Katie's Bar" anytime during normal business hours for the purpose of viewing the liqueur license and conduct bar checks;
- 6. I hereby agree that as owner of Katie's Bar, I will be responsible for the conduct of patrons in my establishment including, but not limited to refusing to serve intoxicated patrons, attempt to dissuade any type of fighting, attempt to not serve under age patrons and utilize best efforts in keeping the noise at a respectable level;
- 7. I hereby take responsibility for my employees conduct while they are at work, whether or not I am on the property;

8. I hereby agree that all staff which serve alcohol beverages will attend, at no cost to me, Carson City Sheriff's Office alcohol server training class on May 30, 2008. My contact for that training is Deputy Jerrod Adams at 887-2020 ext. 45314.
