Subject Title: Action to approve the renaming of Lupin Road to Clear Creek Avenue.

Staff Summary: Lupin Road currently connects South Carson Street to Clear Creek Avenue. There has been a request to push Clear Creek Avenue to South Carson Street, renaming the short piece of Lupin Road, to clarify confusing directions to places on Clear Creek Avenue. (Patrick Pittenger)

Recommended Board Action: I move to approve the renaming of Lupin Road to Clear Creek Avenue.

Explanation for Recommended Board Action: A request has been made to Carson City from the First Church of Christ, Scientist to rename the short segment of road currently named Lupin Road to Clear Creek Avenue. This Action will connect Clear Creek Avenue to South Carson Street at the intersection of South Carson Street and Old Clear Creek Road. There are no addresses currently addressed off of the segment of road that will be renamed, so there are no address changes required for this action. No notices to property owners will be necessary. The road segment north of Clear Creek Avenue, currently named Frontage Road, will be eliminated after the future construction of the Carson City Freeway in this area.






Dear Friends of Carson City:

We support a proposal to rename Lupin Road, a short street segment that connects Clear Creek Avenue with U.S. Highway 395 at the intersection with Old Clear Creek Road in Carson City. Lupin should instead be named simply Clear Creek Avenue, which would then reach all the way to 395 like it used to. This action would solve a transportation problem by making directions much simpler for travelers on Highway 395 who are looking for Clear Creek Avenue.


Even if there were some interesting origin for the name Lupin Road, such as the name of a historical family or after lupine wildflowers, it appears unnecessary to have any name other than Clear Creek Avenue, and it causes a route-finding problem for travelers. Visitors to our church have gotten lost by turning onto Old Clear Creek Road in search of Clear Creek Avenue instead of turning onto Lupin. Driver confusion is not good for traffic safety, either.

We inquired about all this with both the Carson City Transportation staff and with Nevada Department of Transportation. The staffs and managers of both agencies have discussed it with each other. We were advised that a letter of request and support would be appropriate. The State tells us that if Carson City would make that adjustment, NDOT would have no problem with operating accordingly.

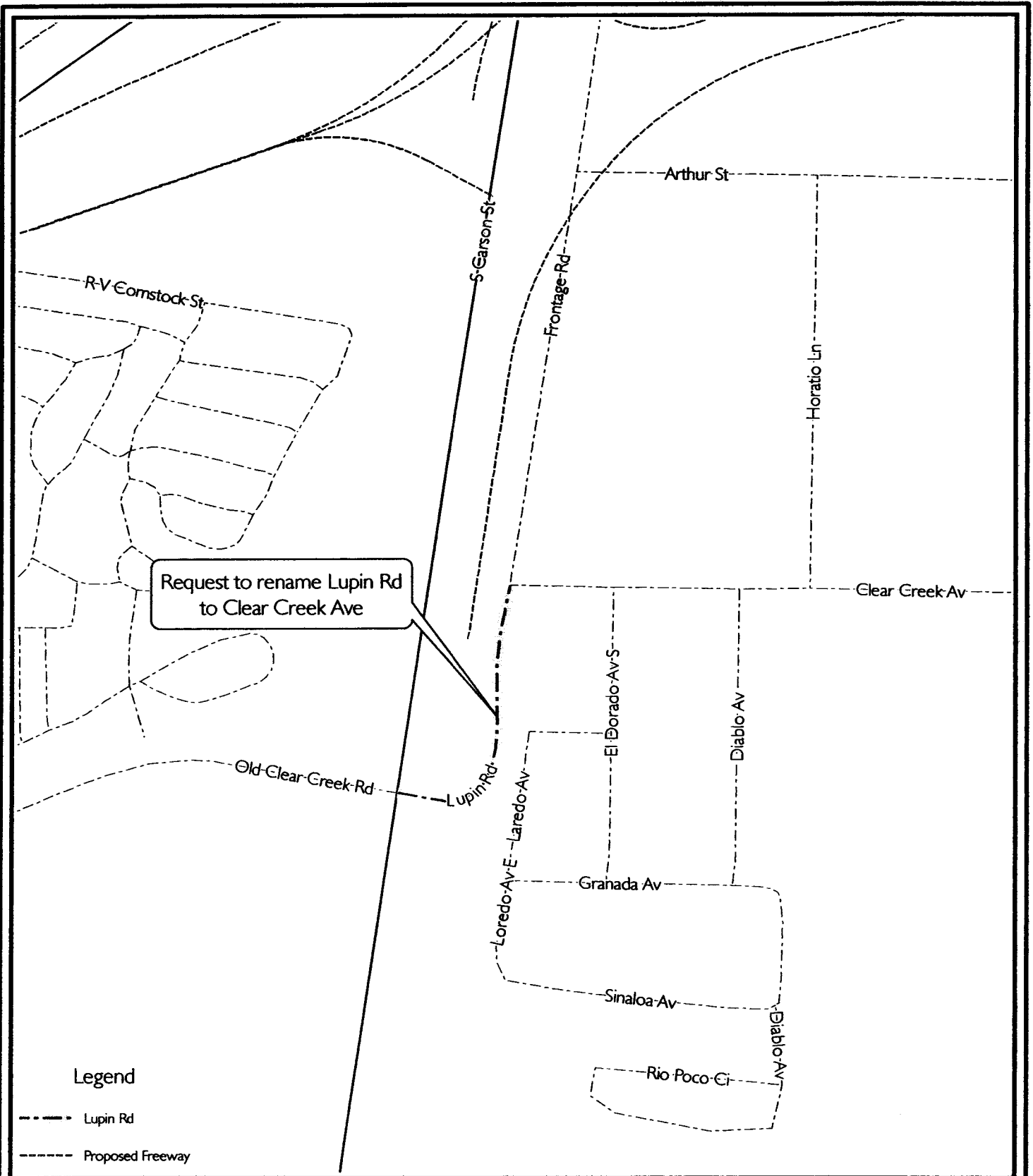
Other churches in addition to ours and many residences are accessed through Clear Creek Avenue, which will be easier for visitors to find when the street name is changed at that intersection.
