ACTION TO APPROVE AN AMENDMENT TO THE CAMPO FISCAL YEAR 2011 UNIFIED PLANNING WORK PROGRAM ("UPWP") (4:35:16) - Chairperson Mallery introduced this item, and Mr. Pittenger reviewed the agenda materials. In response to a question, Ex-Officio Member Taylor expressed doubt that additional funds will be made available. He was unaware of any pending legislation providing for a multi-year transportation bill. Chairperson Mallery entertained additional CAMPO member questions or comments and public comments. Member Des Jardins moved to approve an amendment to the CAMPO fiscal year 2011 Unified Planning Work Program; fiscal impact is an increase of \$110,000. Member Aldean seconded the motion.
