14 \_\_\_\_\_ 1. I understand I have been charged with driving or being in actual physical control of a motor vehicle on  
15 a highway or on premises to which the public has access in Carson City on the \_\_\_\_\_ day  
16 of \_\_\_\_\_, 20\_\_\_\_, in violation of Carson City Municipal Code 10.22.020.

17 2. Initial the proper element:

- 18 \_\_\_\_\_ While under the influence of intoxicating liquor; and/or while having 0.08% or more by weight  
19 of alcohol in my blood or breath; and/or while having a concentration of alcohol of .08 or more  
20 in blood or breath within 2 hours after driving or being in actual physical control of a vehicle.  
21 \_\_\_\_\_ While under the influence of a controlled substance and/or with an amount of a prohibited  
22 substance in my blood or urine that is equal to or greater than that prohibited by law.  
23 \_\_\_\_\_ While under the combined influence of intoxicating liquor and a controlled substance.  
24 \_\_\_\_\_ Having inhaled, ingested, applied or otherwise used any chemical, poison or organic solvent, or  
25 any compound or combination of any of these, to a degree which rendered me incapable of  
safely driving or exercising actual physical control of a vehicle.

**PENALTIES AND RIGHTS:**

\_\_\_\_\_ 3. I understand the City must prove the elements in the above paragraph beyond a reasonable doubt.

\_\_\_\_\_ 4. I understand the following possible punishments:

**1st OFFENSE** in 7 years - A minimum of 2 days, but not more than 6 months in jail or at least 48 hours, but not more than 96 hours of community service in distinctive garb; a fine of not less than \$400, but not more than \$1,000; successful completion of an approved educational course on the abuse of alcohol and controlled substances; attendance at a victim's impact panel; a mandatory alcohol abuse evaluation if the BAC is .18% or more or if the Defendant is under the age of 21; and a 90 day revocation of the Defendant's driver's license by the Department of Motor Vehicles.

**2nd OFFENSE** in 7 years - At least 10 days, but not more than 6 months in jail; a fine of not less than \$750 and not more than \$1,000; or an equivalent number of hours of community service; attendance of a victim's impact panel; a mandatory alcohol abuse evaluation; and revocation of the Defendant's driver's license for a period of one year by the Department of Motor Vehicles.

**3rd OFFENSE** in 7 years - At least 1 year, but not more than 6 years in the Nevada State Prison; a fine of not less than \$2,000, but not more than \$5,000; and revocation of the Defendant's driver's license for a period of 3 years by the Department of Motor Vehicles. Once a person has been convicted of a felony DUI, any subsequent DUI will be a category B felony, punishable by 2 to 15 years in prison if convicted.

\_\_\_\_\_ 5. I understand the City will use this and any other constitutionally valid prior conviction of driving under the influence of alcohol and/or a controlled substances or similar offense to enhance the penalty for any subsequent driving under the influence of alcohol and/or controlled substance during the next 7 years. The period of time in which this conviction can be used against you to enhance the penalty for another offense of Driving Under the Influence (and related offenses) will be longer than seven

years under NRS 484C.400(6). The seven year period is extended by any time you are imprisoned, serving a term of residential confinement, confined in a treatment facility, or are on parole or probation, for this offense.

- \_\_\_\_\_6. I understand I have the right to have an attorney to represent me.
- \_\_\_\_\_7. I understand there are significant dangers and disadvantages to representing myself and the assistance of an attorney can be very valuable in evaluating the facts, applying the law, and presenting my evidence and challenging the City's evidence.
- \_\_\_\_\_8. I understand if I cannot afford an attorney, the Court will appoint one to represent me.  
\_\_\_\_\_ I give up this right to an attorney; or  
\_\_\_\_\_ I am represented by \_\_\_\_\_
- \_\_\_\_\_9. I understand I have the right to a speedy and public trial in front of a Judge and I give up this right.
- \_\_\_\_\_10. I understand I have the right to confront and question all witnesses against me and I give up this right.
- \_\_\_\_\_11. I understand I have the right to subpoena witnesses on my behalf and compel their attendance and I give up this right.
- \_\_\_\_\_12. I understand if I plead guilty now, I have the right to a reasonable delay before sentencing.
- \_\_\_\_\_13. I understand I have the right to a reasonable delay before entering a plea to the charge in this case.
- \_\_\_\_\_14. I understand I have the right to remain silent and not to incriminate myself and I give up this right.
- \_\_\_\_\_15. I understand probation and suspended sentences are not available for any of the above minimum mandatory sentences and the Judge is not bound by any agreement between the parties.
- \_\_\_\_\_16. I understand that by pleading guilty or nolo contendere, I am waiving my right to appeal my conviction except on constitutional or jurisdictional grounds.
- \_\_\_\_\_17. I am voluntarily pleading:  
\_\_\_\_\_ Guilty to the offense as stated in the first paragraph without any promise of leniency or threats having been made because I am in fact guilty of this offense.  
\_\_\_\_\_ Nolo Contendere (No Contest) to the offense as stated in the first paragraph without any promise of leniency or threats having been made because it is in my best interest to do so.
- \_\_\_\_\_ 18. I further acknowledge that I have been advised that if I am not a United States citizen, conviction of this offense can result in deportation, revocation of resident alien status, visa or work permit, denial of re-admission to the United States, and denial of naturalization should I apply.
