Ex-Officio Member Taylor provided an overview of recent legislation, and advised that NDOT staff is in the process of evaluating necessary revisions to the TIPs, to the RTPs, and to NDOT's STP document. He advised that NDOT will produce a 2013 2016 STP "that is not MAP-21 compliant with assurance from [the Federal Highway Administration] that they will still allow us to amend and / or modify the STP accordingly." He advised that the MAP-21 compliant STP is in the process of being developed. In response to a question,

**Explanation for Recommended Action:** Staff is proposing to amend the UPWP to modify the budget to reflect the use of CPG funds. CAMPO, along with FHWA, FTA, NDOT, and Nevada's three other MPOs, recently signed a MOU that allows PL and Section 5303 funds to be combined into one funding source that is reimbursable at a 95 percent rate; requiring a five percent local match. Previously, PL funds were reimbursable at a 95 percent rate, but 5303 funds were only reimbursable at an 80 percent rate, requiring a 20 percent local match.

As required, a 30-day public comment period was noticed and initiated on September 30. A public information meeting regarding the proposed amendment to the UPWP will be held at the Carson City Community Center in the Bonanza Room from 4:00 p.m. to 6:00 p.m. on Tuesday, October 16. Any comments received by staff at the meeting or otherwise will be recorded and presented to CAMPO when staff will seek formal action for approval of the UPWP amendment at the November meeting.

**Explanation for Recommended Action:** Staff is proposing to amend the TIP to include a feasibility study to document the condition and adequacy of an existing facility used to maintain several vehicles in the Carson City fleet, including JAC transit vehicles, as well as to develop a design for a new facility to maintain these vehicles. The feasibility study would include environmental documentation and the development of a staging and financing plan.

Due to the acquisition of new and larger buses, as well as other vehicles used by the Carson City Public Works Department, there is an apparent need to develop a new facility to maintain these vehicles. As the potential facility would not be used exclusively to service transit vehicles, this project would be partially funded with local funds in addition to Federal Transit Administration (FTA) funds and required match. However, the new facility would be designed with two bays dedicated primarily to service transit vehicles.

As required, a 30-day public comment period was noticed and initiated on September 30. A public information meeting regarding the proposed amendment to the TIP will be held at the Carson City Community Center in the Bonanza Room from 4:00 p.m. to 6:00 p.m. on Tuesday, October 16. Any comments received by staff at the meeting or otherwise will be recorded and presented to CAMPO when staff will seek formal action for approval of the TIP amendment at the November meeting.
