Subject Title: Action to approve the interlocal contract between Carson City and Eureka County a request for the Carson City Public Guardian's Office to assume the Guardianship of the Person and Estate of Sharon Gibellini, Ward, in exchange for Eureka County reimbursing the Carson City Public Guardian's Office for services rendered by the Carson City Public Guardian's Office the sum of \$360 per month until the death of the Ward or the removal of the Public Guardian and the sum of \$500 per year for attorney's fees for the attorney representing the Carson City Public Guardian's Office during the Guardianship.

Staff Summary: Eureka County does not currently have a Public Guardian. Therefore, Eureka County seeks to contract with Carson City for the services of the Carson City Public Guardian's Office to assume the Guardianship of Sharon Gibellini. In exchange, Eureka County will pay the Carson City Public Guardian's Office \$360 a month for the services of the Carson City Public Guardian's Office and \$500 a year for attorney's fees for the attorney representing the Carson City Public Guardian's Office. The payment from Eureka County will cover all of our costs over the life of the interlocal agreement.

INTERLOCAL CONTRACT BETWEEN
CARSON CITY AND EUREKA COUNTY

This Interlocal Contract is entered into between Carson City, a political subdivision of the state of Nevada, by and through its duly constituted Board of Supervisors, and Eureka County, a political subdivision of the state of Nevada, by and through its duly constituted Board of Commissioners:

WHEREAS, the parties are authorized by NRS 277.180 to enter into contracts to perform any governmental service, activity or undertaking which any one or more of the agencies are authorized by law to perform; and

WHEREAS, each of the parties is a public agency under NRS 277.100(1)(a); and

WHEREAS, NRS 277.180 authorizes a public agency to enter into an interlocal contract for the purposes set forth herein; and

WHEREAS, Eureka County currently does not have a Public Guardian; and

WHEREAS, Sharon Gibellini, an adult Ward and a resident of Eureka County, has need of continued guardianship; and has no relative or friend residing in Nevada qualified, willing or able to serve as guardian on her behalf and she therefore qualifies for the services of a public guardian pursuant to NRS 253.200;

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein and other good and valuable consideration, Carson City and Eureka County hereby agree as follows:

Carson City Public Guardian's Office shall assume the Guardianship of the Person and Estate of Sharon Gibellini, Ward.

Eureka County shall reimburse the Carson City Public Guardian's Office for their services as Guardian of Sharon Gibellini, Ward, in the amount of Three Hundred Sixty Dollars (\$360.) per month until the death of the Ward, or removal of the Public Guardian, and the sum of Five Hundred Dollars (\$500) annually for attorney's fees for the attorney representing the Carson City Public Guardian's Office during the Guardianship.

Jurisdiction of the Guardianship shall be transferred from the Seventh Judicial District Court, Eureka County, to the First Judicial District Court, Carson City.
