

**Liquor Hearing Officer
Minutes of the Thursday August 10, 2017 Meeting
Carson City Community Development Conference Room A

A Liquor Hearing Officer meeting was scheduled for 1:30 p.m. on Thursday August 10, 2017, in the Carson City Community Development Conference Room A, 108 East Proctor Street, Carson City, Nevada.

A. CALL TO ORDER

(1:29:49) – Ms. Sullivan called the meeting to order at 1:30 p.m.

B. MODIFICATION TO THE AGENDA – None

C. PUBLIC COMMENT – No public was present at this hearing.

D. PUBLIC HEARING: ACTION ITEM

D-1 FOR POSSIBLE ACTION: TO APPROVE A LIQUOR LICENSE FOR CCAS TRANS LLC (LIQUOR LICENSE #18-32121) WITH FRANCIS MAHONEY AS THE LIQUOR MANAGER, LOCATED AT 4949 HWY 50 E A-4.

(1:30:24) – Ms. Sullivan introduced the item and Ms. Reseck noted that there were no changes to the Staff Report which is incorporated into the record. Applicant Representative Lucinda Mahoney introduced herself and acknowledged receipt of the Staff Report and her agreement to the conditions of approval noted within. There were no public comments.

(1:31:20) – Ms. Sullivan approved the liquor license for CCAS Trans LLC, with Francis Mahoney as the liquor manager, located at 4949 Hwy 50 E A-4.

D-2 FOR POSSIBLE ACTION: TO APPROVE A LIQUOR LICENSE FOR SLOTWORLD CABARET (LIQUOR LICENSE #18-32127) WITH MICHAEL PEGRAM AS THE LIQUOR MANAGER, LOCATED AT 324 E. WINNIE LANE.

(1:31:35) – Ms. Sullivan introduced the item and Ms. Reseck informed her that there were no changes to the Staff Report. Ms. Sullivan noted a condition of approval regarding compliance with Nevada Administrative Code 446 (Health Code) with a memo from the Department of Health and Human Services indicating violations at the time of a health inspection. Applicant Michael Pegram introduced himself as a representative of Slotworld and explained that he was unaware of the health code violations identified in the Staff Report. He also believed that they would commence operations on November 1, 2017.

(1:33:03) – Mr. Boothe clarified that the violations were for serving draft beer without a third sink to wash dishes and the required mops to mop up spills. Another sink for handwashing was also required, according to Mr. Boothe, should they wish to continue draft beer sales. Mr. Pegram informed Staff that they would not continue to sell draft beer and they planned to only serve bottled or canned beverages at Slotworld Cabaret, adding that they would do “whatever is necessary” to be compliant. Mr. Boothe noted that they would work with the operator to ensure they are compliant. Ms. Sullivan clarified that she would condition her approval to mandate compliance. There were no public comments.

(1:34:41) – Ms. Sullivan approved the liquor license for Silver Bullet Nevada, LLC (DBA Slotworld Cabaret) located at 324 E. Winnie Lane, with Michael Pegram as the liquor manager. With the following conditions of approval:

- **Mr. Pegram must sign a sworn affidavit consistent with the Municipal Code 4.13.060 regarding a server training course, to give the applicant training on not serving minors.**
- **The facility will need to operate within the requirements of NAC 446, the Nevada Food and Drink Code.**
- **Ms. Sullivan expected the health code compliance to be demonstrated at the time of commencement of operations.**

D-3 For Possible Action: To approve a liquor license for Slotworld (Liquor License #18-32129) with Michael Pegram as the liquor manager, located at 3879 Hwy 50 East.

(1:35:36) – Ms. Sullivan introduced the item and received confirmation from Ms. Reseck that there were no changes to the Staff Report. She also explained that the memo received from the Health Department had addressed both Slotworld properties; therefore the conditions of approval would be the same as those in item D-2. Mr. Pegram acknowledged receipt of the Staff Report and his agreement to the outlined conditions of approval. Mr. Boothe clarified that this particular property did not have any structural violations. Mr. Pegram confirmed that they will be “coming in for permits to do some renovations, so at that point we will bring everything to code”. There were no public comments.

(1:36:59) – Ms. Sullivan approved the liquor license for Silver Bullet of Nevada (DBA Slotworld) at 3879 Highway 50 East, with Michael Pegram as the liquor manager, subject to the following conditions of approval:

- **Mr. Pegram must sign a sworn affidavit consistent with the Municipal Code 4.13.060 regarding a server training course, and all items identified by the Health Department in its inspection of July 25, 2017 must be corrected prior to the commencement of use.**

(1:37:34) – Ms. Sullivan instructed Mr. Pegram to sign the sworn affidavit prepared by Ms. Reseck at the end of the meeting.

E. PUBLIC COMMENT – No public was present.

F. ADJOURNMENT
