**D-1 FOR POSSIBLE ACTION: TO APPROVE A TRANSFER OF LOCATION OF A GENERAL WHOLESALE LIQUOR LICENSE FOR PALIDIN` LLC WITH KURT BROWN REMAINING AS THE LIQUOR MANAGER, FROM 2033 LOMPA LANE #102 TO 3160 N. DEER RUN RD #4.**

Mr. Plemel introduced the item and Ms. Ziegenbein presented the Staff Report which is incorporated into the record. She also clarified that the applicant is amending the application to reflect that the requested license is for liquor distribution, and that the stated marijuana distribution is for a different license. Mr. Plemel indicated that the applicant was a wholesale distributor; therefore the server training requirement would not apply in this case.

Applicant representative Shelly Brown noted that "everything is great" with her application process.

**Mr. Plemel approved the a transfer of location of the general wholesale liquor license for Palidin` LLC with Kurt Brown remaining as the liquor manager, from 2033 Lompa Lane #102 to 3160 N. Deer Run Rd #4, with the amendment outlined above by Ms. Ziegenbein.**
