Vice Chairperson Bonkowski seconded the motion.** Chairperson Kimbrough entertained discussion on the motion and, when none was forthcoming, called for a vote. **Motion carried 6-0.**

**7. INTERNAL COMMUNICATIONS AND ADMINISTRATIVE MATTERS; FUTURE AGENDA ITEMS (4:36:22)** - Chairperson Kimbrough introduced this item, and Ms. Maloney proposed cancelling the December CAMPO meeting. Chairperson Kimbrough entertained questions or comments; however, none were forthcoming.

**8. CAMPO MEMBER COMMENTS (4:36:57)** - Chairperson Kimbrough entertained CAMPO member comments. Ex-Officio Member Rosenberg advised that the State Transportation Board meeting took place earlier in the day. She thanked Ms. Maloney for attending and for participating as a speaker. Ex-Officio Member Rosenberg reported that NDOT's One-Nevada Plan was approved and that the transparency, partnership, and collaboration of the plan was highly commended. Ex-Officio Member Rosenberg announced the closure of I-580 during certain hours of the upcoming weekend in order that power lines can be repaired.
