Application for Service Information

Application with Carson City Utility Billing for water-sewer service is in accordance with the following terms and conditions:

- 1. The Applicant, whose signature is on file by date of appearance, has made application for water-sewer service to be supplied at the address indicated on file, and upon request to be supplied at any other local address to which he/she may purchase.
- The applicant agrees that service arrangements are subject to the rules, regulations and tariffs of Carson City Water/Sewer billing Department as filed with the Carson City Treasurer at present in force, or that may be adopted hereafter.
- The Applicant owns the property for which service is applied and agrees to pay for said service as bills are rendered therefore in accordance with said rules, regulations and tariffs with the Carson City Treasurer and in effect at the time of delivery.
- 4. A \$20 establishment fee will be charged for each new account and will appear on the first or second bill.
- 5. Applicant is aware that wasting water is prohibited in Carson City. The city imposes water restriction each year from June 1st through September 30th. These restrictions are due to delivery and storage limitations, not supply shortages. Odd-numbered addresses water on Tuesday, Thursday, and Saturday. Even-numbered addresses water on Sunday, Wednesday, and Friday, with no watering by anyone on Monday. During this time, watering is not allowed between 10 a.m. and 6 p.m., the hours when water evaporation is at its highest.

Water Restriction Exemptions

- 1. Licensed commercial gardeners or commercial caretakers who are on the premises at the time watering are taking place.
- 2. Vegetable gardens, flower beds and trees within two months of planting.
- 3. New lawns are exempt from watering restrictions for 21 days from planting or installation date.
- 4. Residential customers adjusting and repairing their irrigation system during the non-watering times for a time period not to exceed one hour.

An application must be filled out with the Utility Department for an exemption at 887.2355.

Initial residential monthly sewer bills are assigned at the statistical average of six thousand gallons. Sewer bills are automatically revised by computer in April each year according to your household sewer impact, based on wintertime water use while you are not watering outside.
