A special meeting of the Carson City Board of Supervisors was held on Thursday, November 9, 2000, at the Community Center Sierra Room, 851 East William Street, Carson City, Nevada, beginning at 12 Noon.

CALL TO ORDER, ROLL CALL, PLEDGE OF ALLEGIANCE - Mayor Masayko convened the meeting at 12 noon. Roll call was taken. A quorum was present although Supervisor Bennett was absent. Mayor Masayko lead the Pledge of Allegiance.

CITIZEN COMMENTS (1-0029) - None.

CLERK-RECORDER - Alan Glover

A. ACTION TO APPROVE THE CANVASS OF THE VOTE FOR THE NOVEMBER 7, 2000, GENERAL ELECTION (1-0031) - Mr. Glover explained the purpose of the meeting. He then presented the canvass of the vote and highlighted the election results. He thanked his staff, other City staff members, the Nevada Division of Forestry crew, Information Services, and the election workers for their dedication and efforts to make the process flow smoothly. Consensus indicated it was fortunate the problems encountered in Florida were far away. Discussion explained the closing process and questioned the City's early completion ranking. Mr. Glover also noted the unfortunate occurrences encountered with individuals who failed to register but desired to vote. He encouraged the residents to register and vote in all elections. Mayor Masayko suggested that they verify their registration early in the process. Mayor Masayko also thanked the election staff for its help in determining several electors' voting areas. Mr. Glover complimented the candidates on their professionalism during the election. Problems encountered in previous elections were limned to illustrate the need for professionalism. Discussion explained that the Statute for counting absentee ballots mandates that only those received by 7 p.m. on election day are counted. Other States have different requirements. Supervisor Williamson explained the reception her daughter received when she voted for the first time and thanked the precinct workers for their recognition. Mr. Glover indicated that election recommendations regarding the equipment will be submitted in the future. Mayor Masayko indicated that the election results were public records and could be examined at the Clerk's office. Supervisor Williamson moved to approve the canvass of the vote for the November 7, 2000, General Election. Supervisor Plank seconded the motion. Motion carried 4-0.

B. ACTION TO APPROVE A RESOLUTION DESIGNATED BY THE SHORT TITLE "2000 CARSON CITY SCHOOL DISTRICT CANVASS RESOLUTION", DECLARING THE RESULTS OF AN ELECTION HELD WITHIN CARSON CITY SCHOOL DISTRICT IN CARSON CITY IN THE STATE OF NEVADA, ON THE GENERAL OBLIGATION SCHOOL BOND QUESTION SUBMITTED AT THE ELECTION HELD ON TUESDAY, NOVEMBER 7, 2000, TO THE QUALIFIED ELECTORS OF THE DISTRICT; PROVIDING OTHER MATTERS RELATING THERETO; AND PROVIDING THE EFFECTIVE DATE HEREOF (1-0192) - Mayor Masayko congratulated the electorate and School District on the successful campaign. Supervisor Plank moved to adopt Resolution 2000-R-51, A RESOLUTION DESIGNATED BY THE SHORT TITLE "2000 CARSON CITY SCHOOL DISTRICT CANVASS RESOLUTION", DECLARING THE RESULTS OF AN ELECTION HELD WITHIN CARSON CITY SCHOOL DISTRICT IN CARSON CITY IN THE STATE OF NEVADA, ON THE GENERAL OBLIGATION SCHOOL BOND QUESTION SUBMITTED AT THE ELECTION HELD ON TUESDAY, NOVEMBER 7, 2000, TO THE

QUALIFIED ELECTORS OF THE DISTRICT; PROVIDING OTHER MATTERS RELATING THERETO;
AND PROVIDING THE EFFECTIVE DATE HEREOF. Supervisor Livermore seconded the motion. Motion
carried 4-0.

Mayor Masayko thanked Mr. Glover and his staff for its professionalism.

There being no other matters for consideration, Supervisor Plank moved to adjourn. Mayor Masayko seconded the
motion. Motion carried unanimously. Mayor Masayko adjourned the meeting at 12:15 a.m.
