13 \_\_\_\_\_ I understand that I have been charged with placing graffiti on any church, cemetery, school, grounds  
14 adjacent to & owned or rented by any institution, any personal property contained in any institution in  
15 violation of NRS 206.125.

16 \_\_\_\_\_ I understand that the State must prove all of the elements of this crime beyond a reasonable doubt.

17 \_\_\_\_\_ I understand in addition to any other penalty, the court shall order a person found guilty of a gross  
18 misdemeanor pursuant to NRS 206.125, subsection 1 to pay restitution for the damage and;

19 \_\_\_\_\_ I understand if I plead or am found guilty of violating NRS 206.125 the court shall include an  
20 administrative assessment of \$250 for each violation in addition to any other fine or penalties.

21 \_\_\_\_\_ I understand in addition to any other penalty, my driver's license is subject to suspension by the Nevada  
22 Department of Motor Vehicles.

23 \_\_\_\_\_ I understand the above possible punishments, and that they may be subject to increased severity for future  
24 offences:

25 1<sup>st</sup> OFFENSE: A fine of not less than \$400 but not more than \$1,000, and 100 hours of community service.

2<sup>nd</sup> OFFENSE: A fine of not less than \$750, but not more than \$1,000, and 200 hours of community service.

3<sup>rd</sup> OR SUBSEQUENT OFFENSE: A fine of \$1,000, and 200 hours of community service.

\_\_\_\_\_ I understand that I have the right to have an attorney represent me, and if I cannot afford an attorney the  
Court will appoint one, and I am represented as noted below, or, with knowledge of the dangers and  
disadvantages of self representation, I elect to represent myself.

\_\_\_\_\_ I understand that I have the right to a speedy and public trial and I give up this right.

\_\_\_\_\_ I understand that I have the right to confront and question all witnesses against me and I give up this right.

\_\_\_\_\_ I understand that I have the right to subpoena witnesses on my behalf and compel their attendance and I  
give up this right.

\_\_\_\_\_ I understand that I have the right to remain silent and not incriminate myself and I give up this right.

\_\_\_\_\_ I am voluntarily pleading guilty/nolo contendere to the offense as state in the first paragraph without any  
promises of lenience or threats having been made because I am in fact guilty of this offense and/or because  
I believe the State can prove the offense beyond a reasonable doubt. I understand that any state may use  
this conviction to enhance the penalty for any future related offense.

\_\_\_\_\_ I further acknowledge that I have been advised that if I am not a United States citizen, conviction of this  
offense can result in deportation, revocation of resident alien status, visa or work permit, denial of re-  
admission to the United States, and denial of naturalization should I apply.
