**A. CALL TO ORDER**

(1:32:59) – Mr. Plemel called the meeting to order at 1:32 p.m. and explained the hearing process noting that “this was an administrative hearing”; however, it provided the public an opportunity to voice their comments.

**B. MODIFICATION TO THE AGENDA** – None

**C. PUBLIC COMMENT** – No public was present at this hearing.

**D. PUBLIC HEARING: ACTION ITEM**

**D-1 FOR POSSIBLE ACTION: TO APPROVE A WHOLESALE LIQUOR LICENSE FOR GREAT BASIN BEVERAGE LLC (LIQUOR LICENSE #18-21845) WITH ALAN BLACH AS THE LIQUOR MANAGER, LOCATED AT 534 PACIFIC AVENUE, WELLS NV.**

(1:33:37) – Ms. Reseck introduced the item and presented the Staff Report which is incorporated into the record. Mr. Plemel explained that the applicants were not present because the Carson City Municipal Code allowed wholesale liquor distributors holding a current liquor license in another county, in this case Elko, do not have to appear in person, and will not be subject to a background check. Mr. Plemel also referenced a copy of the applicant’s current license which is incorporated into the record.

**(1:34:58) – Mr. Plemel approved a liquor license for Great Basin Beverage, LLC, located at 534 Pacific Avenue, Wells, Nevada, with Alan Blach as the liquor manager, and specifically for wholesale liquor distribution.**

**D-2 FOR POSSIBLE ACTION: TO APPROVE A WHOLESALE LIQUOR LICENSE FOR A&J DISTRIBUTORS LLC (LIQUOR LICENSE #18-32115) WITH ANDY HUMPHRISS AS THE LIQUOR MANAGER, LOCATED AT 2326 PRIMO WAY, SPARKS NV.**

(1:35:29) – Mr. Plemel introduced the item. Ms. Reseck presented the Staff Report, incorporated into the record, and noted that this applicant was also a wholesale distributor. She referenced a copy of their current liquor license from

Sparks, adding that similar to the reasons outlined in item D-1, the applicants need not be present.

**(1:35:59) – Mr. Plemel approved a wholesale liquor license for A&J Distributors, LLC, located at 2326 Primo Way, [Sparks, Nevada] with Andy Humphriss as the liquor manager.**
