**D. PUBLIC HEARING: ACTION ITEM**

**D-1 FOR POSSIBLE ACTION: TO APPROVE A LIQUOR LICENSE FOR BLESS UP LLC (LIQUOR LICENSE #18-32318) WITH NITISH SACHAR AS THE LIQUOR MANAGER, LOCATED AT 2707 HWY 50 EAST.**

Mr. Plemel introduced the item and Ms. Reseck presented the Staff Report which is incorporated into the record. Mr. Plemel addressed both applicants when he stressed the importance of server training and the consequences of serving minors. Applicant Nitish Sachar introduced himself and acknowledged receipt of the Staff Report and his agreement to the conditions of approval noted within.

**Mr. Plemel approved the liquor license for Bless Up LLC (Liquor License #18-32318) with Nitish Sachar as the liquor manager, located at 2707 Hwy 50 East, subject to the conditions of approval contained in the Staff Report.**

**D-2 FOR POSSIBLE ACTION: TO APPROVE A LIQUOR LICENSE FOR FLAVORS OF INDIA (LIQUOR LICENSE #18-32236) WITH MANPREET KAUR AS THE LIQUOR MANAGER, LOCATED AT 1105 S. CARSON STREET.**

Ms. Reseck introduced the item and presented the Staff Report which is incorporated into the record. Manpreet Kaur

introduced herself and acknowledged receipt of, and agreement to, the conditions of approval. Ms. Kaur also noted that they are working with the Department of Health and Human Services to obtain the appropriate approvals for a December 2, 2017 opening date.
