**Staff Summary:** This will be the second reading of an ordinance to modify the text of the Carson City Municipal Code by adopting the latest version (2018) of the International Fire Code and the International Wildland-Urban Interface Code together with the Northern Nevada Amendments to form the basis for the City's fire code. The proposed changes would become effective January 1, 2019.

The first reading of the ordinance was on September 20, 2018. It was passed unanimously by the Board of Supervisors.

## **Background/Issues & Analysis**

All the regional governments in Northern Nevada have followed a six (6) year cycle for code adoption and a regional amendment package. The last edition of the International Fire Code that was adopted was the 2012 edition in 2013. In order to provide consistent levels of safety, staff recommends adopting the 2018 International Fire Code, International Wildland-Urban Interface Code, and Northern Nevada Amendments.
