**SUBJECT:** Liquor License: Maria's Mexican Restaurant (Liquor License #19-33244)

**Recommendation:** To approve a dining room with a hard liquor license for Antonio Ortega-Avila dba Maria's Mexican Restaurant at 1939 North Carson Street with Antonio Ortega-Avila as the liquor manager subject to the following conditions of approval:

1. The applicant must sign a sworn affidavit consistent with CCMC 4.13.060 regarding a server training course.

Per Carson City Municipal Code 4.13, all liquor license requests are to be reviewed by the Hearings Officer. The Hearings Officer may grant or deny the application for a liquor license or place conditions on a license to ensure compliance with the Municipal Code. The Hearings Officer considers the recommendation of the Sheriff's office and the Health Department in making his decision.

The subject request is to allow Antonio Ortega-Avila dba Maria's Mexican Restaurant to have a dining room with a hard liquor license, with Antonio Ortega-Avila as the liquor manager. The applicant is seeking to operate a Mexican restaurant. The business is located at 1939 N. Carson St.

This request has been reviewed by both the Health Department and the Sheriff's Office. The Health Department inspected the premises and is recommending approval.

The Sheriff's office conducted a background check and did not find any disqualifying information based on CCMC 4.13.125.
