



MANDATORY SINGLE-FAMILY DWELLING (Residential) SOLID WASTE SERVICE EXEMPTION

Effective July 1, 2019, trash (solid waste) removal service will be mandatory for all residents in Carson City. Residential customers will be provided a 96-gallon solid waste cart, 96-gallon recycling cart, and 96-gallon yard waste cart ahead of the contract start date. The monthly base rate \$17.59 will then be billed quarterly to customers for this mandatory collection service. Recycling and yard waste services are optional. It is the customer's responsibility to contact Waste Management at (775) 343-7596 to request changes.

Customers who routinely self-haul their trash (solid waste) to the Carson City Landfill on Flint Drive may apply for an exemption from mandatory collection service. The following are required for service exemption:

- Original receipts demonstrating landfill usage at least six (6) consecutive months prior to July 1, 2020. Photocopies of receipts will not be accepted.

or

- Original receipts demonstrating landfill usage at least twelve (12) consecutive months for any period after July 1, 2020. Photocopies of receipts will not be accepted.

and

- This signed exemption application.

Residential customers may apply for a collection service exemption with six (6) consecutive months of landfill receipts after June 1, 2019. Applications must be submitted at the Waste Management office at 5560 Sheep Drive, Carson City, NV 89701. Records will be kept on file at this location.

Customers who do not have the necessary six (6) months of original receipts for an exemption application by July 1, 2019, will be required to pay (approximately \$17.59 per month) for mandatory collection service until they have accumulated enough landfill receipts for their exemption application. Please note the minimum charge at Carson City Landfill is \$10.00 per visit. *No credits or refunds will be given to customers for months of overlapping collection service and landfill use.*

To maintain a service exemption, residential customers must provide twelve (12) months of original landfill receipts each year on or before the anniversary of their initial exemption. In the event a customer does not provide appropriate documentation, a 96-gallon solid waste cart, 96-gallon recycling cart and 96-gallon green waste cart will be delivered to the customer's address. An activation fee (\$50.30) will be applied in addition to the current monthly rate, which will be billed quarterly. (The activation fee is not charged during the initial roll out in July 2019.) Exemption application guidelines are set out in the franchise agreement with Waste Management, which was approved by the Carson City Board of Supervisors on December 20, 2018. Residential customers should not apply for this exemption unless they are sure that they will haul material to the landfill at least one (1) time per month.
