REPRESENTATIVE FROM THE NEVADA LIBRARY COOPERATIVE WILL PRESENT THE COOPERATIVE'S STRATEGIC PLAN AND THE MEMBERS NEEDS ASSESSMENT.

Vice Chairperson Long introduced the item. Nevada Library CoOp Director Cindy O introduced herself and gave background on her previous meeting with the Board when she had received feedback. She also noted the benefits of the CoOp to the Nevada Libraries.

Consultant Ruth Metz, Ruth Metz Associates, introduced herself and presented the Nevada Library Cooperative Members' Needs Assessment and the 2019-2023 Strategic Plan, both of which are incorporated into the record. Ms. Metz also introduced Tod Colegrove, Nevada State Librarian, and responded to clarifying questions by the Trustees. Mr. Colegrove clarified that the CoOp and the Nevada State Library will play different roles and defined his role as a facilitator. Ms. Metz referenced her presentations and noted that the general survey consensus pointed out that the CoOp services must continue. She also pointed out bureaucracy as a weakness. Ms. Metz outlined the milestones, incorporated into the record, of the Strategic Plan and encouraged the development of milestone-based work plans, progress reviews twice per year, an annual celebration of accomplishments along with milestone updates, and the revisiting of trends, vision and strategy every two years. Mr. Colegrove thanked Ms. Baker for her support of the CoOp.

Vice Chair Long stated that she liked the Plan; however, Staff had to "live it" and encouraged their feedback. Access Services Manager Ermal Reinhart inquired about the process and Ms. Metz indicated that Ms. O will "activate" the milestones and facilitate Board participation. Ms. Baker noted that the connection with the Nevada State Library was very important. Trustee Solinger suggested non-monetary certificate for participation as part of the celebration milestone. Trustee Patton was informed that the brochures would be general and for all libraries, not customized. Discussion ensued regarding additional staffing, if needed, and Ms. Baker noted that some of the deliverables will be "a stretch" which Trustee Patton called a challenge.
