2020 "I VOTED" STICKER DESIGN CONTEST
OFFICIAL RULES**

By submitting an entry, you agree to be bound by the below-stated "Official Rules" of the contest:

1. Sponsor: This contest is hosted by the Carson City Clerk's Office and sponsored by the Carson City Department of Arts & Culture.

2. Eligibility: Participants must:

- Be a resident of Carson City, Nevada; and
- Be currently enrolled in the 9th through 12th grade (or equivalent for home-schooled students).

3. How to Enter: Designs must be submitted electronically to msalinas@carson.org, by 5:00 p.m. on April 20, 2020. To submit your design, you must include the 2020 "I Voted" Sticker Design Entry Form and Consent Form with the design.

Late entries will not be accepted.

4. Design Rules: Entries must comply with the following guidelines to be eligible:

- All design work must be completed by the student participant, and only the student participant;
- A limit of two entries will be permitted per participant;
- No entry fee is required;
- Content cannot be sexually explicit or suggestive, or derogatory of any ethnic, racial, gender, religious, professional or age group;
- Content cannot promote alcohol, illegal drugs, tobacco, firearms/weapons, or any particular political agenda or message;
- Content cannot defame, misrepresent or contain disparaging remarks about other people or companies;
- Designs must be entirely original and cannot contain trademarks, logos, trade dress, or copyrighted materials owned by others without permission of the owner;
- Content cannot contain material embodying the names, likeness, photographs, or other indicia identifying any person, living or dead, without permission;
- Content cannot communicate message or images inconsistent with the positive images and/or goodwill to which the Sponsor wishes to associate; and
- Content cannot depict and cannot itself be in violation of any law or otherwise.

Sponsor reserves the right to disqualify any entry for any reason, in its sole and absolute discretion.

5. Design Requirements: The design must include the phrase "I Voted" and reflect the theme of voting or elections in Carson City, Nevada, and/or the United States. The dimensions should design should be circular, with a 2.5" diameter, and sent electronically as a .jpeg at a resolution of 400dpi.

6. Selection: On April 29, 2020, two participants will be selected as finalists and receive \$100 for their designs. The finalist will be selected on May 6, 2020. The finalist's design will be used by the Carson City Clerk's Office during the Primary Election Early Voting (May 23, 2020-June 5, 2020) and the Primary Election Voting Day (June 6, 2020).

By signing this Consent and Entry Form:

1. I hereby agree to participate in the 2020 "I Voted" Sticker Design Contest hosted by Carson City (hereinafter "the City") and the Carson City Department for Arts & Culture (hereinafter "the Sponsor"), and irrevocably grant my permission and authorize the use of my name, school, artwork, and photograph, by the City or Sponsor in any non-commercial manner. For the purpose of this limitation, the name, school, artwork, or photograph on materials design to market or promote the City or the Sponsor, or any other function or property of the City or Sponsor, shall be deemed to be a non-commercial use.
2. I further agree that the design submitted belongs entirely and exclusively to the Sponsor, so that the Sponsor and its licensees and assigns may duplicate, distribute, broadcast, exhibit, or otherwise use the design without limitation or restriction. The Sponsor may edit the design as it deems appropriate.
3. I understand and agree that I do not own any rights in the design, nor will I receive any monetary compensation for its use by the Sponsor. I am granting the Sponsor a free, non-exclusive, irrevocable license to use my design to fulfill the purposes of this contest. I acknowledge that the Sponsor has no obligation to use my design in the contest.
4. I hereby attest that the design submitted is entirely of my own skill and creativity, and that I did not assign the creative or artistic portions of the design to another party. Any design submitted as a part of this Contest shall comply with all applicable patent, trademark and copyright laws, rules, regulations and codes of the United States. I agree that the design will not utilize any protected patent, trademark or copyright unless I have retained proper permission and all releases and other necessary documentation. If I utilize any protected materials, I shall disclose such patents, trademarks, and/or copyrights in my application. I understand that failure to comply with this provision may be cause for disqualification from the contest, at the sole discretion of the Sponsor.
5. I agree to release, indemnify and hold harmless the City, the Sponsor, and its officers and employees from any and all claims, damages, suits, costs, expenses, liabilities, actions or proceedings of any kind resulting from a design submitted in this Contest which infringes upon any patent, trademark, or copyright that is protected by law.
6. I agree that I shall not make any claims against the City nor the Sponsor based upon the distribution or use of the material submitted as a part of this Contest. I release the City and the Sponsor and its licensees and its assigns from any and all claims and liabilities which may occur in relation to or arising from my participation in this Contest. I agree that this consent and release will be governed by and construed in accordance with the law of Carson City, Nevada.
7. I confirm that I am a resident of Carson City, Nevada.
8. I agree to participate in this Contest, as described in the 2020 "I Voted" Sticker Design Contest Official Rules.
9. I certify and acknowledge that I have read, understood and agree to the Official Rules of the contest; that I have read this Consent prior to signing it; and I consent to provide the information necessary to enter the contest and if selected, to be awarded a finalist or winner.
